### **Consumer Benefits**

- 24-Hour Emergency Roadside Assistance: Provides towing of up to twenty five (25) miles and includes battery assistance, lock-out assistance, flat tire assistance and emergency delivery of gasoline, water, oil or any supplies necessary to get your customer back on their way.
- Windshield Repair: Repairs front windshield if it becomes chipped or cracked due to propelled rocks or road hazard debris while driving on public roads, streets and highways. Does not cover windshield replacement.
- Paintless Dent Repair: PDR utilizes special tools and techniques to push dented sheet metal back to its original form. Permanently removes door dings and minor dents without harming a vehicle's factory finish. No paint is required, provides permanent repair on minor dents and dings and won't harm your vehicle's factory paint finish. Coverage not available for large or deep dents, dents where there is any paint damage, and dents that are the result of any sort of weather event (i.e. hail damage).
- Tire & Wheel Road Hazard Protection: Provides for tire repair/replacement and/or wheel (rim) repair/replacement in the event tires and/or wheels become damaged due to a Road Hazard. Road Hazard is defined as a condition on a public roadway, which should not exist there such as potholes, nails, glass or other road debris.









- Ideal for leased vehicles providing coverage over and above the new vehicle limited warranty.
- Will not increase automobile insurance premiums if used.
- Paintless Dent Repair and Windshield Repair services can be performed at your customer's home, place of employment or at the originating dealership.

# **Eligibility**

- New and Pre-Owned vehicles are eligible for coverage.
- Eligible vehicles include current model year plus ten (10) years prior.
- Commerical vehicles are excluded.
- All claims MUST have prior authorization.
- Only available at the time of vehicle purchase.

- The Windshield Repair Protection benefit is not available in the state of FL.
