Theft Program Coverages

In the event that your vehicle is A) stolen and not recovered, or in the event that it is B) recovered but declared to be a total loss, you will become eligible for the following:

- A cash benefit you can use towards the purchase or lease of a replacement vehicle, to cover your deductible, or to apply towards any other expenses that you may encounter.
- Down Payment Assistance when you return to your selling dealership, an additional benefit will be paid towards the down payment on a replacement vehicle.

In the event that your vehicle is C) stolen and recovered damaged (but not totaled), you will be eligible for reimbursement of up to \$1,000 to cover your primary insurance deductible.
